DEFINITION

Seasonal **part-time** position (while school is in session). Assist with activities, and provide a safe and educational environment for all the youth enrolled in the City's After School Program.

SUPERVISION RECEIVED AND EXERCISED

Receives direction from After School Program Supervisors.

Exercises no direct supervision of employees.

ESSENTIAL FUNCTION STATEMENTS – *Essential duties may include, but are not limited to, the following:*

Essential Functions:

1. Oversees and fosters a safe environment for all youth activities.
2. Plans and initiates activities that are beneficial for the participants.
3. Enforces all safety rules and regulations in a professional manner.
4. Maintains a positive attitude at all times and reflects that attitude in all relationships with the public and youth involved in the program.
5. Assists with the upkeep, maintenance, and daily cleaning of the camp base site.

6. Performs other duties as assigned.
7. Accurately completes all necessary paperwork in a timely manner.
8. Attends work regularly as scheduled, remaining alert at all times.

Marginal Functions:

1. Works after hours and on weekends as needed.
2. Represents the Parks and Recreation department to the citizens, other departments, elected officials and outside agencies; meets and greets the public.
3. Supports all youth, volunteer, civic and cultural activities in which the City participates.
4. Attends various meetings and seminars as required.
5. Performs related duties and responsibilities as required.
6. Attends work regularly, as scheduled.

QUALIFICATIONS

Ability to:

Work well with children and adults and communicate clearly and accurately.
Assume responsibility of providing direct care and supervision to the youth participants.

Perform basic record keeping skills.

Interpret and apply applicable Federal, State and local policies, laws and regulations.

Communicate clearly and concisely, both orally and in writing.

Establish and maintain effective working relationships with those contacted in the course of work.

Maintain effective audio-visual discrimination and perception needed for:

- making observations
- reading and writing
- communicating with others

Maintain mental capacity which permits:

- making sound decisions and using good judgment
- communicating clearly

Maintain physical condition appropriate to the performance of assigned duties and responsibilities which may include the following:

- standing or sitting for extended periods of time
- above average physical activities
- exposure to the elements

Effectively handle a work environment and conditions which involve:

- working closely with others
- exposure to the elements

WORKING CONDITIONS

Environmental Conditions:

Inside and outside conditions; exposure to inclement weather.

Physical Conditions:

Essential and marginal functions may require maintaining physical condition necessary for sitting, standing, or walking for prolonged periods of time as well as above average physical activities; adequate speech, hearing, and eyesight required; may be required to carry, push, pull, drag or hold light to moderate weight objects up to 50 lbs.
